

A BILL FOR AN ACT

To amend Public Law No. 20-95 by amending section 5 thereof, to change the use of funds previously appropriate therein, to fund public projects and social programs for the people of Chuuk state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 20-95 is hereby  
2 amended to read as follows:

3 "Section 5. Of the \$2,800,000 appropriated under this act,  
4 \$1,200,000 shall be apportioned for public projects and social  
5 programs for the people of Chuuk State.
