Approving and accepting a \$250,000 grant from the U.S. Department of Health and Human Services, to fund for the Opioid State Targeted Response Program, including all the terms and conditions of the assistance.

1 WHEREAS, on April 18, 2018, the United States through the
2 Department of Health and Human Services issued a Grant Award to
3 the FSM Department of Health and Social Affairs in the amount
4 of \$250,000 to support the FSM Department of Health and Social
5 Affairs' Opioid State Targeted Response Program; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended,
8 requires that for foreign financial assistance to be valid it
9 must be approved by Congress by resolution; now, therefore,

10 BE IT RESOLVED by the Twentieth Congress of the Federated
11 States of Micronesia, Fourth Regular Session, 2018, that
12 Congress hereby approves and accepts the \$250,000 grant from
13 the U.S. Department of Health and Human Services, to fund the
14 Opioid State Targeted Response Program, including all of the


