A RESOLUTION

Approving and accepting a grant in the amount of \$147,000 from the U.S. Department of Health and Human Services, Health Resources and Service Administration (HRSA), to fund for the Maternal and Child Health Services Program in the FSM, including all the terms and conditions of the assistance.

1           WHEREAS, on May 07, 2018, the United States through the  
2 Department of Health and Human Services, Health Resources and  
3 Service Administration (HRSA) issued the Grant Award in the  
4 amount of \$147,000 to fund and support the FSM Maternal and  
5 Child Health Services Program for the budget period starting  
6 from October 01, 2017, to September 30, 2019; and

7           WHEREAS, the grant shall provide financial support to the  
8 FSM Maternal and Child Health Services Program in its  
9 implementation's efforts towards the health of women, children,  
10 and their families in the FSM; and

11           WHEREAS, section 210(2) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended,  
13 requires that for an agreement on foreign financial assistance  
14 to be valid it must be approved by Congress by resolution; now,  
15 therefore,

16           BE IT RESOLVED by the Twentieth Congress of the Federated  
17 States of Micronesia, Fourth Regular Session, 2018, that  
18 Congress hereby approves and accepts the \$147,000 grant from  
19 the U.S. Department of Health and Human Services, Health

1 Resources and Service Administration, to fund the Maternal and  
2 Child Health Services Program in the FSM, including all the  
3 terms and conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this  
5 resolution be transmitted to the President of the Federated  
6 States of Micronesia, the Secretary of the Department of Health  
7 and Social Affairs, and the U.S. Embassy in Kolonia.


