A RESOLUTION

Approving and accepting a grant from the United Nations Children's Fund (UNICEF) in the amount of \$673,037, to fund the implementation of the Federated States of Micronesia-UNICEF Programme of Cooperation 2018-2022 and 2018-2019 Work Plan, including all the terms and conditions of the assistance.

1 WHEREAS, the Pacific Representative of the United Nations
2 Children's Fund (UNICEF) extended to the Government of the
3 Federated States of Micronesia a grant in the amount of
4 \$673,037 as evidenced by the attached FSM-UNICEF Programme of
5 Cooperation 2018-2022 and 2018-2019 Work Plan signed by the
6 Government of the Federated States of Micronesia on May 30,
7 2018 and UNICEF on May 25, 2018; and

8 WHEREAS, the purpose of the grant is to fund and support
9 the implementation of the following programs in the 2018-2019
10 Work Plan which are aligned towards the FSM's Strategic
11 Development Plan: 1) water, sanitation, and hygiene work plan,
12 2) education work plan, 3) child protection, 4) policy evidence
13 and social protection plan, and 5) health and nutrition work
14 plan; and

15 WHEREAS, the SPF-PFS grant is a five year project and this
16 is the fourth year of this grant; and

17 WHEREAS, section 210(2) of title 55 of the Code of the
18 Federated States of Micronesia (Annotated), as amended,
19 provides that for an agreement on foreign financial assistance

1 to be valid it must be approved by Congress by resolution; and

2 WHEREAS, the FSM Government is grateful and appreciative
3 to UNICEF for its benevolent financial assistance; now,
4 therefore,

5 BE IT RESOLVED by the Twentieth Congress of the Federated
6 States of Micronesia, Fourth Special Session, 2018, that
7 Congress hereby approves and accepts the \$673,037 grant from
8 the United Nations Children's Fund, to fund the implementation
9 of the FSM-UNICEF Programme of Cooperation 2018-2022 and 2018-
10 2019 Work Plan, including all the terms and conditions thereof;
