APPROVING AND ACCEPTING A GRANT IN THE AMOUNT OF \$291,556 FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES, CENTERS FOR DISEASE CONTROL AND PREVENTION, TO FUND AND SUPPORT THE IMPLEMENTATION OF THE FSM'S CCC PLAN TO REDUCE CANCER BURDEN IN THE FSM, FOR THE BUDGET PERIOD FROM JUNE 30, 2018, TO JUNE 29, 2019, INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

Approving and accepting a grant in the amount of \$291,556 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and support the implementation of the FSM's CCC plan to reduce cancer burden in the FSM, for the budget period from June 30, 2018, to June 29, 2019, including all the terms and conditions of the assistance.

1 WHEREAS, U.S. Department of Health and Human Services,
2 Centers for Disease Control and Prevention, issued a Notice of
3 Grant Award on June 15, 2018, in the amount of \$291,556, and

4 WHEREAS, the purpose of the grant is to fund and support
5 the project entitled: "Implementing FSM's CCC Plan to Reduce
6 Cancer Burden in the FSM" including the FSM Comprehensive
7 Cancer Control Program's operational costs of personnel,
8 salaries and other expenses necessary for the program; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended,
11 requires that for foreign financial assistance to be valid it
12 must be approved by Congress by resolution; and

13 WHEREAS, the FSM Government expresses appreciation to the
14 United States Government for the federal grant programs made
15 available to the Federated States of Micronesia; now,
16 therefore,

17 BE IT RESOLVED by the Twentieth Congress of the Federated
18 States of Micronesia, Fourth Special Session, 2018, that

1 Congress hereby approves and accepts the \$291,556 grant from
2 the U.S. Department of Health and Human Services, Centers for
3 Disease Control and Prevention, to support and fund the FSM
4 Comprehensive Cancer Control Program and its activities and
5 services, of implementing the FSM CCC Plan to reduce cancer
6 burden in the FSM, including all the terms and conditions
7 thereof; and

8 BE IT FURTHER RESOLVED that certified copies of this
9 resolution be transmitted to the President of the Federated
10 States of Micronesia, the Secretary of the Department of Health
11 and Social Affairs, and the United States Embassy in Kolonia.


