A RESOLUTION

Approving and accepting a grant in the amount of \$1,156,180 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to support and fund the FSM Immunization and Vaccines for Children Program, including all the terms and conditions of the assistance.

1           WHEREAS, on June 22, 2018, the United States through the  
2 Department of Health and Human Services, Centers for Disease  
3 Control and Prevention, issued a Notice of Award of financial  
4 assistance in the amount of \$1,156,180 to fund the FSM program  
5 entitled: "FSM Immunization and Vaccines for Children" for  
6 budget the period from April 01, 2017 to June 30, 2019, and

7           WHEREAS, the grant shall help support the FSM Immunization  
8 and Vaccines for Children Program's efforts in planning,  
9 developing and maintaining a public health workforce that helps  
10 assure a high immunization coverage level and a low incidence  
11 of vaccine-preventable disease, as well as improving the  
12 ability to respond to public health threats; and

13           WHEREAS, section 210(2) of title 55 of the Code of the  
14 Federated States of Micronesia (Annotated), as amended,  
15 requires that for foreign financial assistance to be valid it  
16 must be approved by Congress by resolution; now, therefore,

17           BE IT RESOLVED by the Twentieth Congress of the Federated  
18 States of Micronesia, Fourth Special Session, 2018, that  
19 Congress hereby approves and accepts the \$1,156,180 grant from





1 the U.S. Department of Health and Human Services, Centers for  
2 Disease Control and Prevention, to fund the FSM Immunization  
3 and Vaccines for Children Program, including all the terms and  
4 conditions thereof; and
