A RESOLUTION

Approving and accepting a grant in the amount of \$922,587 from the U.S. Department of Education, Division of Special Education Program, for the Federal Fiscal Year 2018 fund under Part B of the Individual with Disabilities Education Act (IDEA), including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Notice of Award of financial assistance on
3 June 26, 2018, for Phase 1 for the federal funding period from
4 July 01, 2018, to September 30, 2019, in the amount of
5 \$922,587; and

6 WHEREAS, the purpose of this grant is to fund and assist
7 the implementation of the FSM Department of Education, Division
8 of Special Education programs and services provided to eligible
9 children with disabilities including their families throughout
10 the FSM; and

11 WHEREAS, section 210(2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended,
13 requires that for foreign financial assistance to be valid it
14 must be approved by Congress by resolution; and

15 WHEREAS, the FSM Government expresses appreciation to the
16 United States Government for the federal grant programs made
17 available to the Federated States of Micronesia; now,
18 therefore,

19 BE IT RESOLVED by the Twentieth Congress of the Federated

1 States of Micronesia, Fifth Special Session, 2018, that
2 Congress hereby approves and accepts the \$922,587 grant from
3 the U.S. Department of Education, including all the terms and
4 conditions of the assistance; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated
7 States of Micronesia, the Secretary of the Department of
8 Education and the United States Embassy in Kolonia.
