A RESOLUTION

Setting the ceiling of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2018.

1 WHEREAS, section 104 of title 55 of the Code of the
2 Federated States of Micronesia (Annotated), as amended,
3 requires that Congress adopt a resolution setting forth the
4 total funds to be available from the General Fund and any
5 special funds of the Treasury of the Federated States of
6 Micronesia for each fiscal year; now, therefore


7 BE IT RESOLVED by the Twentieth Congress of the Federated
8 States of Micronesia, Fifth Regular Session, 2018, that the
9 amount estimated to be available for the fiscal year ending
10 September 30, 2018, is set at \$201,117,120 of which
11 \$194,252,250 is from domestic revenues, and \$5,252,250 will be
12 available from amended Compact Sector for COM-FSM and
13 \$1,612,620 will be available from the Supplemental Education
14 Grant; and


1 BE IT FURTHER RESOLVED that certified copies of this
