

A RESOLUTION

Approving and accepting a grant in the amount of \$693,970 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and support the FSM Public Health and Healthcare Emergency Preparedness Project, including all the terms and conditions of the assistance.

1           WHEREAS, on July 05, 2018, the United States through the  
2 Department of Health and Human Services, Centers for Disease  
3 Control and Prevention, issued a Notice of Award of grant  
4 assistance in the amount of \$693,970 to fund and support the  
5 project entitled: "FSM Public Health and Healthcare Emergency  
6 Preparedness Project"; and

7           WHEREAS, the purpose of this grant is to fund the  
8 implementation of the FSM Public Health and Healthcare  
9 Emergency Preparedness Project; and

10           WHEREAS, section 210(2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended,  
12 requires that for foreign financial assistance to be valid it  
13 must be approved by Congress by resolution; now, therefore,

14           BE IT RESOLVED by the Twentieth Congress of the Federated  
15 States of Micronesia, Fifth Regular Session, 2018, that  
16 Congress hereby approves and accepts the \$693,970 grant from  
17 the U.S. Department of Health and Human Services, Centers for  
18 Disease Control and Prevention, to fund the FSM Public Health  
19 and Healthcare Emergency Preparedness Project, including all

1 the terms and conditions thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this  
3 resolution be transmitted to the President of the Federated  
4 States of Micronesia, the Secretary of the Department of Health  
5 and Social Affairs, and the United States Embassy in Kolonia.


