Approving and accepting a grant from the United Nations Development Programme (UNDP) in the amount of \$290,386, to fund and support the Global Fund Project for HIV/TB in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Development Programme, extended
2 to the Government of the Federated States of Micronesia a grant in
3 the amount of \$290,386, as evidenced by a Letter of Assurance
4 dated July 23, 2018; and

5 WHEREAS, the purpose of the grant is to fund the project
6 entitled: "Multi-Country Western Pacific Integrated HIV/TB
7 Program" in the FSM for the next two years 2019-2020; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended,
10 provides that for foreign financial assistance to be valid it
11 must be approved by Congress by resolution; now, therefore,

12 BE IT RESOLVED by the Twentieth Congress of the Federated
13 States of Micronesia, Fifth Regular Session, 2018, that
14 Congress hereby approves and accepts the \$290,386 grant from
15 the United Nations Development Programme (UNDP), to fund the
16 Global Fund Project for HIV/TP in the FSM, including all the
17 terms and conditions thereof; and




1 BE IT FURTHER RESOLVED that certified copies of this
