A RESOLUTION

Approving and accepting a grant in the amount of \$666,397 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to provide funding to the Federated States of Micronesia, Department of Health and Social Affairs for prevention and treatment services related to substance abuse for the budget period from October 01, 2018, to September 30, 2019, including all the terms and conditions of the assistance.

1           WHEREAS, the United State through the Department of Health  
2 and Human Services, Substance Abuse and Mental Health  
3 Administration, issued a Notice of Award of grant assistance on  
4 August 20, 2018, in the total amount of \$666,397 and

5           WHEREAS, the purpose of the grant is to provide funding to  
6 help support, plan, implement, and evaluate activities that  
7 prevent and treat substance abuse and promote public health;  
8 and

9           WHEREAS, section 210(2) of title 55 of the Code of the  
10 Federated States of Micronesia (Annotated), as amended,  
11 provides that for foreign financial assistance to be valid it  
12 must be approved by Congress by resolution; now, therefore,

13           BE IT RESOLVED by the Twentieth Congress of the Federated  
14 States of Micronesia, Fifth Regular Session, 2018, that  
15 Congress hereby approves and accepts the \$666,397 grant from  
16 the U.S. Department of Health and Human Services, Substance  
17 Abuse and Mental Health Administration, to provide funding  
18 support to the FSM Department of Health and Social Affairs for

1 prevention and treatment services related to substance abuse,  
2 including all the terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated  
5 States of Micronesia, the Secretary of the Department of Health  
6 and Social Affairs, and the United States Embassy in Kolonia.


