A RESOLUTION

Approving and accepting a grant in the amount of \$240,000 from the U.S. Department of Health and Human Services, Public Health Services Administration, to support and fund the FSM Family Planning Program, including all the terms and conditions of the assistance.

1           WHEREAS, on August 30, 2018, the United State through the  
2 U.S. Department of Health and Human Services, Public Health  
3 Services Administration, issued a Notice of Award for financial  
4 assistance in the amount of \$240,000, to fund and support the FSM  
5 Family Planning Program for Fiscal Year 2019; and

6           WHEREAS, the purpose of the grant is to fund and support  
7 the implementation of the FSM Family Planning Program to ensure  
8 accessibility of an effective contraceptive of choice to  
9 improve the overall health status of women of child bearing age  
10 in the FSM; and


11           WHEREAS, section 210(2) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended,  
13 provides that for foreign financial assistance to be valid it  
14 must be approved by Congress by resolution; now, therefore,

15           BE IT RESOLVED by the Twentieth Congress of the Federated  
16 States of Micronesia, Fifth Regular Session, 2018, that  
17 Congress hereby approves and accepts the \$240,000 grant from  
18 the U.S. Department of Health and Human Services, Public Health  
19 Services Administration, to fund the FSM Family Planning


1 Program, including all the terms and conditions thereof; and
