4 Regents of the College of Micronesia-FSM, representing Kosrae
5 State; and

6 WHEREAS, the resolution approving that nomination has not
7 been adopted and, under 2 F.S.M.C. §207, the nomination may not
8 be resubmitted by the President during the Twentieth Congress
9 without authorization from Congress; and

10 WHEREAS, the President has nominated Mr. Tulensru E. Waguk
11 to serve as a member of the Board of Regents of the College of
12 Micronesia-FSM, representing Kosrae State; now, therefore,

13 BE IT RESOLVED by the Twentieth Congress of the Federated
14 States of Micronesia, Fifth Regular Session, 2018, that
15 Congress hereby authorizes the President to resubmit the
16 nomination of Mr. Tulensru E. Waguk to serve as a member of the
17 Board of Regents of the College of Micronesia-FSM, representing
18 Kosrae State; and


