A RESOLUTION

To confirm the nomination of Dr. Elizabeth Iehsi Keller to serve as a member of the FSM MiCare Board of Directors representing the state of Pohnpei.

1 WHEREAS, pursuant to section 407 of title 52 of the Code
2 of the Federated States of Micronesia (Annotated), as amended,
3 the President has nominated Dr. Elizabeth Iehsi Keller to serve
4 as a member of the FSM MiCare Board of Directors, representing
5 the state of Pohnpei; and

6 WHEREAS, Dr. Keller is qualified to continue serving as
7 board member of MiCare based on her educational background and
8 long years of experience in public service, including her
9 service as Director of the Department of Health for Pohnpei
10 State, and as medical doctor holding various posts in the state
11 of Pohnpei; and

12 WHEREAS, appointment to the MiCare Board of Directors
13 requires the advice and consent by the Congress of the
14 Federated States of Micronesia; now, therefore,

15 BE IT RESOLVED by the Twentieth Congress of the Federated
16 States of Micronesia, Sixth Special Session, 2018, that
17 Congress hereby confirms the nomination of Dr. Elizabeth Iehsi
18 Keller to serve as a member of the MiCare Board of Directors,
19 representing Pohnpei State; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Governor of each state of the Nation,
4 and Dr. Elizabeth Iehsi Keller.


