A RESOLUTION

1           WHEREAS, in accordance with section 201(1) of title 24 of  
2 the Code of the Federated States of Micronesia (Annotated), as  
3 amended, the Board of Directors of the National Oceanic  
4 Resource Management Authority ("the Board") is composed of five  
5 member; and

6           WHEREAS, section 201(1)(b) of title 24 of the Code of the  
7 Federated States of Micronesia (Annotated), as amended,  
8 empowers the President of the Federated States of Micronesia to  
9 appoint one at-large member of the Board with the advice and  
10 consent of Congress; and

11           WHEREAS, the President has nominated Mr. Jack to  
12 represent the National Government on the NORMA Board of  
13 Directors, and the nomination is subject to the advice and  
14 consent of Congress; and

15           WHEREAS, Mr. Jack is qualified to serve as a member of  
16 the Board of Directors based on his educational attainment and  
17 professional experience; now, therefore,

18           BE IT RESOLVED by the Nineteenth Congress of the  
19 Federated States of Micronesia, Sixth Special Session, 2018,  
20 that Congress hereby confirms the nomination of Mr. Grilly Jack

1 to serve as a member of the NORMA Board of Directors,  
2 representing the National Government; and


3 BE IT FURTHER RESOLVED that certified copies of this
