1 WHEREAS, in accordance with section 201(1) of title 24 of
2 the Code of the Federated States of Micronesia, as amended by
3 Public Law No. 15-38, the Board of Directors of the National
4 Ocean Resource Management Authority is composed of five
5 members; and

6 WHEREAS, section 201(1)(a) of title 24 of the Code of the
7 Federated States of Micronesia, as amended by Public Law No.
8 15-38, empowers the President of the Federated States of
9 Micronesia to appoint one member from each FSM state with the
10 advice and consent of Congress; and

11 WHEREAS, the President has nominated Mr. Roger Arnold to
12 represent the state of Chuuk on the NORMA Board; and

13 WHEREAS, Mr. Roger Arnold is qualified to serve as a NORMA
14 Board member based on his educational attainment and
15 professional experience; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Sixth Special Session, 2018, that
18 Congress hereby confirms the nomination of Mr. Roger Arnold to
19 serve as a NORMA Board member representing the state of Chuuk;

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Governor of each state of the Nation,
4 and Mr. Roger Arnold.
