1 WHEREAS, in accordance with section 201(1) of title 24 of the
2 Code of the Federated States of Micronesia, as amended by Public
3 Law No. 15-38, the Board of Directors of the National Oceanic
4 Resource Management Authority is composed of five members; and

5 WHEREAS, section 201(1)(a) of title 24 of the Code of the
6 Federated States of Micronesia, as amended by Public Law No. 15-38,
7 empowers the President of the Federated States of Micronesia to
8 appoint one member from each FSM state with the advice and consent
9 of Congress; and

10 WHEREAS, the President has nominated Mr. Nena M. William to
11 represent the state of Kosrae on the NORMA Board; and

12 WHEREAS, Mr. William is qualified to serve as a NORMA Board
13 member based on his educational attainment and professional
14 experience; now, therefore,

15 BE IT RESOLVED by the Twentieth Congress of the Federated
16 States of Micronesia, Sixth Special Session, 2018, that Congress
17 hereby confirms the nomination of Mr. Nena M. William to serve as
18 a NORMA Board member representing the state of Kosrae; and


