A RESOLUTION

1 WHEREAS, pursuant to section 306 of title 21 of the Code
2 of the Federated States of Micronesia (Annotated), as amended
3 by Public Law No. 18-52, the President of the Federated States
4 of Micronesia shall appoint the members of the
5 Telecommunication Regulation Authority (the "Authority"),
6 subject to the advice and consent of Congress, for a term of
7 four years; and

15 Congress hereby confirms the nomination of Mr. Mathias Lawrence
16 to serve as member of the Telecommunication Regulation

4 and Mr. Mathias Lawrence.


