RESOLUTION

Approving and accepting a grant in the amount of \$250,000 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA), to support and fund FSM Department of Health and Social Affairs Opioid State Targeted Response Project, including all the terms and conditions of the assistance.

1 WHEREAS, on September 19, 2018, the United State through
2 the Department of Health and Human Services, Substance Abuse
3 and Mental Health Services Administration, issued a Notice of
4 Award for financial assistance in the amount of \$250,000 to
5 fund and support the project entitled: " Federated States of
6 Micronesia Opioid State Targeted Response"; and

7 WHEREAS, the purpose of the grant is to increase access to
8 treatment, reduce unmet treatment need, and reduce opioid
9 overdose related deaths through the provision of prevention,
10 treatment and recovery activities for opioid use disorder
11 including prescription opioids as well as illicit drugs such as
12 heroin; and

13 WHEREAS, this is the second year of this financial
14 assistance for budget period for September 30, 2018 to
15 September 30, 2019; and

16 WHEREAS, section 210(2) of title 55 of the Code of the
17 Federated States of Micronesia (Annotated), as amended, provides
18 that for foreign financial assistance to be valid it must be

1 approved by Congress by resolution; now, therefore,

2 BE IT RESOLVED by the Twentieth Congress of the Federated
3 States of Micronesia, Sixth Special Session, 2018, that Congress
4 hereby approves and accepts the \$250,000 grant from the U.S.
5 Department of Health and Human Services, Substance Abuse and
6 Mental Health Administration, to fund the FSM Department of Health
7 and Social Affairs Opioid State Targeted Response Project,
8 including all the terms and conditions thereof; and

9 BE IT FURTHER RESOLVED that certified copies of this
10 resolution be transmitted to the President of Federated States of
11 Micronesia, the Secretary of the Department of Health and Social
12 Affairs and the U.S. Embassy in Kolonia.
