Approving and accepting a grant in the amount of \$108,197 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Preventive Health and Health Services Project, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services,
2 Centers for Disease Control and Prevention, issued a Grant
3 Award to the FSM Department of Health and Social Affairs on May
4 20, 2018, in the amount of \$108,197 to fund the FSM Department
5 of Health and Social Affairs' Preventive Health and Health
6 Services Project; and

7 WHEREAS, the purpose of this grant is to assist in
8 achieving the National Health Promotion and Disease Prevention
9 Objectives in Healthy People 2020; and

10 WHEREAS, the FSM Government expresses appreciation to the
11 U.S. Department of Health and Human Services, Centers for
12 Disease Control and Prevention, for providing these funds; and

13 WHEREAS, section 210(2) of title 55 of the Code of the
14 Federated States of Micronesia (Annotated), as amended,
15 provides that for an agreement on foreign financial assistance
16 to be valid it must be approved by Congress by resolution; now,
17 therefore,

18 BE IT RESOLVED by the Twentieth Congress of the Federated
19 States of Micronesia, Sixth Special Session, 2018, that

1 Congress hereby approves and accepts the \$108,197 grant from
2 the U.S. Department of Health and Human Services, Centers for
3 Disease Control and Prevention, to fund the FSM Preventive
4 Health and Health Services Project, including all the terms and
5 conditions of the assistance; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 resolution be transmitted to the President of Federated States
8 of Micronesia and the Secretary of the Department of Health and
9 Social Affairs.
