A RESOLUTION

Approving and accepting a grant in the amount of \$853,081 from the U.S. Department of Education, Division of Special Education Program, for the Federal Fiscal Year 2017 fund under Part B of the Individual with Disabilities Education Act (IDEA), including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Notice of Award for financial assistance on
3 June 30, 2017, for Phase 1 for the federal funding period from
4 July 01, 2017, to September 30, 2018, in the amount of \$853,081;
5 and

6 WHEREAS, the purpose of this grant is to fund and assist the
7 implementation of the FSM Special Education's programs and
8 services to eligible children with disabilities including their
9 families throughout the FSM; and

10 WHEREAS, section (2) of title 55 of the Code of the Federated
11 States of Micronesia (Annotated), as amended, provides that for
12 foreign financial assistance to be to be valid it must be approved
13 by Congress by resolution; and

14 WHEREAS, the FSM Government expresses appreciation to the
15 United States Government for the federal grant programs made
16 available to the Federated States of Micronesia; now, therefore,

17 BE IT RESOLVED by the Twentieth Congress of the Federated
18 States of Micronesia, Second Regular Session, 2017, that Congress
19 hereby approves and accepts the \$853,081 grant from the U.S.

1 Department of Education, including all the terms and conditions
2 thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia and the Secretary of the Department of Education.




