A RESOLUTION

Approving and accepting a grant in the amount of \$164,968 from the U.S. Department of Health and Human Services, Health Resources and Services Administration, to fund the FSM Maternal and Child Health Services Program, for the budget period from October 01, 2016, to September 30, 2018, for the improvement of mothers and children's health in the FSM, including all the terms and conditions of the assistance.

1           WHEREAS, the United States through the Department of Health  
2 and Human Services, Health Resources and Services Administration,  
3 issued a Notice of Award of financial assistance on July 19, 2017,  
4 in the amount of \$164,968; and

5           WHEREAS, the purpose of this grant is to fund the Maternal  
6 and Child Health Services Program in the FSM; and


7           WHEREAS, section 210(2) of title 55 of the Code of the  
8 Federated States of Micronesia provides that for an agreement on  
9 foreign financial assistance to be valid it must be approved by  
10 Congress by resolution; now, therefore,


11           BE IT RESOLVED by the Twentieth Congress of the Federated
