A RESOLUTION

Approving and accepting a grant in the amount of \$337,000 from the U.S. Department of Health and Human Services, Public Health Service, to support and fund the FSM Family Planning Program, including all the terms and conditions of the assistance.

1           WHEREAS, on June 20, 2017, the United States through the  
2 Department of Health and Human Services, Public Health Service,  
3 issued the Notice of Award for financial assistance in the amount  
4 of \$337,000, to fund and support the FSM Family Planning Program  
5 for the Fiscal Year 2018; and

6           WHEREAS, the purpose of this grant is to fund and support the  
7 implementation of the FSM Planning Program to ensure accessibility  
8 of an effective contraceptive of choice to improve the overall  
9 health status of women of child bearing age in the FSM; and


10           WHEREAS, section 210(2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended, provides  
12 that for foreign financial assistance be valid it must be approved  
13 by Congress by resolution; now, therefore,


14           BE IT RESOLVED by the Twentieth Congress of the Federated
