A RESOLUTION

Approving and accepting a grant from the U.S. Federal Aviation Administration (FAA) in the amount of \$500,000 to provide funding for the Kosrae International Airport, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. FAA has approved a federal funding
2 application for the improvement of the Kosrae International
3 Airport, in particular, for a project entitled: "Improve Airport
4 Miscellaneous Improvements – Design Electric Vault", which was
5 lodged with the U.S. FAA in 2015; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; now, therefore,

10 BE IT RESOLVED by the Twentieth Congress of the Federated
11 States of Micronesia, Second Regular Session, 2017, that Congress
12 hereby approves and accepts the \$500,000 grant from the U.S. FAA,
13 to fund the Kosrae International Airport, including all the terms
14 and conditions thereof; and




