A RESOLUTION

To confirm the nomination of Ms. Alissa R. Takesy to serve as a member of the National Scholarship Board representing the National Government of the Federated States of Micronesia.

1 WHEREAS, section 392 of title 40 of the Code of the Federated
2 States of Micronesia (Annotated), as amended, provides that the
3 National Scholarship Board ("the Board") shall consist of five
4 (5) voting members, including one from the National Government
5 and one from each state of the Federated States of Micronesia,
6 who shall be recommended by the Governor of the relevant state;
7 and

8 WHEREAS, each such recommended member of the Board shall be
9 nominated by the President with the advice and consent of the
10 Congress; and

11 WHEREAS, the President of the Federated States of Micronesia
12 has nominated Ms. Alissa R. Takesy to serve on the Board as the
13 representative from the FSM National Government; and

14 WHEREAS, Ms. Alissa R. Takesy has the experience and
15 qualifications which make her a suitable candidate to serve on
16 the Board; now, therefore,

17 BE IT RESOLVED by the Twentieth Congress of the Federated
18 States of Micronesia, Second Special Session, 2017, that
19 Congress hereby confirms the nomination of Ms. Alissa R. Takesy
20 to serve as a member of the Federated States of Micronesia

1 National Scholarship Board, representing the FSM National
2 Government; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Education, and
6 Ms. Alissa R. Takesy.


