A RESOLUTION

Approving and accepting a grant in the amount of \$276,806 from the U.S Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Public Health and Healthcare Emergency Preparedness project, including all the terms and conditions of the assistance.

1 WHEREAS, on July 26, 2017, the United States through the
2 Department of Health and Human Services, Centers for Disease
3 Control and Prevention, issued a Notice of Award of financial
4 assistance in the amount of \$276,806, to fund and support the
5 project entitled: "FSM Public Health and Healthcare Emergency
6 Preparedness Project"; and

7 WHEREAS, the purpose of the grant is to fund the
8 implementation of the FSM Public Health and Healthcare Emergency
9 Preparedness Project; and

10 WHEREAS, this is the second grant award for the budget period
11 from July 01, 2017, to June 30, 2018; and

12 WHEREAS, section 210 (2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended, provides
14 that for an agreement on foreign financial assistance to be valid
15 it must be approved by Congress by resolution; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Second Regular Session, 2017, that Congress
18 hereby approves and accepts the \$276,806 grant from the U.S.
19 Department of Health and Human Services, Centers for Disease

1 Control and Prevention, to fund the FSM Public Health and
2 Emergency Preparedness Project, including all the terms and
3 conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated States
6 of Micronesia, the Secretary of the Department of Health and
7 Social Affairs, and the United States Embassy in Kolonia.
