A RESOLUTION

To confirm the nomination of Mr. Alfred Ansin to serve as a member of the Board of Directors for Caroline Island Air (CIA), representing the State of Chuuk.

1 WHEREAS, section 6 of Public Law No. 10-72, as amended by
2 Public Laws Nos. 10-103 and 16-26, the President of the Federated
3 States of Micronesia shall appoint the members of the Board of
4 Directors of Caroline Island Air, subject to the advice and
5 consent of Congress; and

6 WHEREAS, pursuant to the recommendation made by the
7 Governor of the state of Chuuk the President has nominated Mr.
8 Alfred Ansin to serve as a member of the Board of Directors,
9 representing the state of Chuuk; and

10 WHEREAS, Mr. Ansin's professional experience and
11 qualifications make him a suitable candidate to serve as a member
12 of the Board of Directors of Caroline Island Air; and

13 WHEREAS, pursuant to Public Law No. 10-72, as amended by
14 Public Law No. 16-26, Board members are appointed to serve a three
15 year terms; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Second Special Session, 2017, that Congress
18 hereby confirms the nomination of Mr. Alfred Ansin to serve as a
19 member of the Board of Directors of Caroline Island Air,
20 representing the state of Chuuk; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Governor of the state of Chuuk, the Board of
4 Directors of Caroline Island Air, and Mr. Alfred Ansin.


