A RESOLUTION

Approving and accepting a grant in the amount of \$665,810 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Service Administration, to provide funding for prevention and treatment services related to substance abuse for the budget period from October 01, 2016, to September 30, 2018, including all the terms and conditions of the assistance.

1           WHEREAS, the United States through the Department of Health  
2 and Human Services, Substance Abuse and Mental Health Service  
3 Administration, issued a Notice of Award of financial assistance  
4 on August 31, 2017, in the amount of \$665,810; and

5           WHEREAS, the purpose of the grant is to provide awareness of  
6 the consequences of alcohol, tobacco, and other substance abuse,  
7 and to provide treatment and recovery services to individuals  
8 suffering from substance abuse; and

9           WHEREAS, section 210(2) of title 55 of the Code of the  
10 Federated States of Micronesia (Annotated), as amended, provides  
11 that for an agreement on foreign financial assistance to be valid  
12 it must be approved by Congress by resolution; now, therefore,

13           BE IT RESOLVED by the Twentieth Congress of the Federated  
14 States of Micronesia, Second Regular Session, 2017, that Congress  
15 hereby approves and accepts the \$665,810 grant from the U.S.  
16 Department of Health and Human Services, Substance Abuse and  
17 Mental Health Service Administration, to fund for prevention and

1 treatment services related to substance abuse, including all the  
2 terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated States  
5 of Micronesia, the Secretary of the Department of Health and  
6 Social Affairs and the United States Embassy in Kolonia.


