A RESOLUTION

Approving and accepting a grant in the amount of \$647,309 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to fund the FSM Strategic Prevention Framework Partnerships for Success (SPF-PFS) Project, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of Health
2 and Human Services, Substance Abuse and Mental Health Services
3 Administration, issued a Notice of Award on June 26, 2017, for the
4 budget period from September 30, 2017 to September 29, 2018, in
5 the amount of \$647,309; and

6 WHEREAS, the purpose of the grant is to fund the FSM Project
7 entitled: "Strategic Prevention Framework Partnerships for
8 Success" in its effort to enhance the current underage drinking
9 issues throughout the Nation as well as funding the others
10 activities and services under the FSM Behavioral Health and
11 Wellness Program; and

12 WHEREAS, the SPF-PFS grant is a five year project and this is
13 the fourth year of this grant; and

14 WHEREAS, section 210 (2) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, requires
16 that for an agreement on foreign financial assistance to be valid
17 it must be approved by Congress by resolution; and

1 WHEREAS, the FSM Government expresses appreciation to the
2 United States Government for the federal grant programs made
3 available to the Federated States of Micronesia; now, therefore,

4 BE IT RESOLVED by the Twentieth Congress of the Federated
5 States of Micronesia, Second Special Session, 2017, that Congress
6 hereby approves and accepts the \$647,309 grant from the U.S.
7 Department of Health and Human Services, Substance Abuse and
8 Mental Health Services Administration, to fund the SPF-PFS Project
9 including all the terms and conditions thereof; and

10 BE IT FURTHER RESOLVED that certified copies of this
11 resolution be transmitted to the President of the Federated States
12 of Micronesia and the Secretary of the Department of Health and
13 Social Affairs.
