A RESOLUTION

Approving and accepting a grant in the amount of \$800,000 from the Government of the People's Republic of China, to subsidize the newly launched airline between the FSM and Papua New Guinea, including all the terms and conditions of the assistance.

1 WHEREAS, the Government of the People's Republic of China
2 donated \$800,000 to the Government of the Federated States of
3 Micronesia to subsidize the newly launched airline between the FSM
4 and Papua New Guinea on December 3, 2016; and

5 WHEREAS, section 210(2) of title 55 of the Code of the
6 Federated States of Micronesia (Annotated), as amended, requires
7 that for foreign financial assistance to be valid it must be
8 approved by Congress by resolution, and

9 WHEREAS, the Government of the Federated States of Micronesia
10 wishes to express its appreciation to the Government of the
11 People's Republic of China; now, therefore,

12 BE IT RESOLVED by the Twentieth Congress of the Federated
13 States of Micronesia, Third Special Session, 2017, that Congress
14 hereby approves and accepts the \$800,000 grant from the People's
15 Republic of China to subsidize the newly launched airline between
16 the FSM and Papua New Guinea, including all the terms and
17 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the FSM Department of Foreign Affairs, the FSM
4 Department of Justice, the FSM Embassy in China, and the Chinese
5 Embassy in Palikir.


