A RESOLUTION

Approving and accepting the small scale grant aid project from the Korea International Cooperation Agency, in the amount of \$200,000, to assist in the improvement of the Kosrae International Airport facilities in the state of Kosrae, including all the terms and conditions of the assistance.

1 WHEREAS, on November 29, 2016, the Government of the
2 Republic of Korea through the Korea International Cooperation
3 Agency extended a grant to the Federated States of Micronesia
4 in the amount of \$200,000 for the improvement of the Kosrae
5 International Airport facilities; and

6 WHEREAS, the grant made pursuant to the small scale grant
7 aid project will be directed towards the improvement of the
8 Kosrae International Airport terminal arrival lobby,
9 immigration and customs inspection areas, restrooms and baggage
10 claim areas; and

11 WHEREAS, section 210(2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended,
13 provides that for an agreement on foreign financial assistance
14 to be valid it must be approved by Congress by resolution; now,
15 therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Second Special Session, 2017, that
18 Congress hereby approves and accepts the \$200,000 grant from
19 the Korea International Cooperation Agency to assist in the

1 improvement of the Kosrae International Airport facilities,
2 including all the terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Foreign Affairs,
6 and Embassy of the Republic of Korea in Fiji.


