A RESOLUTION

Approving and accepting a grant in the amount of \$3,032,657 from the U.S. Department of Education for the Federal Fiscal Year 2018 fund under Part B of the Individuals with Disabilities Education Act, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Grant Award Notification on October 1, 2017,
3 for Phase 2 for the federal funding period from July 01, 2017, to
4 September 30, 2018, in the amount of \$3,032,657; and

5 WHEREAS, the purpose of this grant is to fund and assist the
6 implementation of the FSM Special Education's programs and
7 services to eligible children with disabilities including their
8 families throughout the FSM; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; and

13 WHEREAS, the FSM Government expresses appreciation to the
14 United States Government for the federal grant programs made
15 available to the Federated States of Micronesia; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Third Special Session, 2017, that Congress
18 hereby approves and accepts the \$3,032,657 grant from the United
19 States Department of Education for the Federal Fiscal Year 2018

1 fund under Part B of the Individuals with Disabilities Education
2 Act, including all the terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the Secretary of the Department of Education and
6 the U.S. Embassy in Kolonia.
