A RESOLUTION

Approving and accepting a grant in the amount of \$100,064 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the PPHF 2017 Preventive Health and Health Services Block Grant, for the budget period from October 01, 2016, to September 30, 2018, including all the terms and conditions of the assistance.

1           WHEREAS, the United States through the Department of Health  
2 and Human Services, Centers for Disease Control and Prevention,  
3 issued a Notice of Award of financial assistance on March 09,  
4 2017, in the amount of \$100,064; and

5           WHEREAS, the purpose of the grant is to fund the program  
6 entitled: "Preventive Health and Health Services Funded Solely  
7 with Prevention and Public Health Funds (PPHF)", including the  
8 program's operational costs and other activities necessary for the  
9 implementation of the program; and

10           WHEREAS, section 210 (2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended, requires  
12 that for an agreement on foreign financial assistance to be valid  
13 it must be approved by Congress by resolution; and

14           WHEREAS, the FSM Government expresses appreciation to the  
15 United States Government for the federal grant programs made  
16 available to the Federated States of Micronesia; now, therefore,

17           BE IT RESOLVED by the Twentieth Congress of the Federated  
18 States of Micronesia, Second Special Session, 2017, that Congress

1 hereby approves the \$100,064 grant from the U.S. Department of  
2 Health and Human Services, Centers for Disease Control and  
3 Prevention, to fund the PPHF 2017 Preventive Health and Health  
4 Services Block Grant, including all the terms and conditions  
5 thereof; and

6 BE IT FURTHER RESOLVED that certified copies of this  
7 resolution be transmitted to the President of the Federated States  
8 of Micronesia and the Secretary of the Department of Health and  
9 Social Affairs.
