THIRD SPECIAL SESSION, 2017 CONGRESSIONAL RESOLUTION NO. 20-67, C.D.1

A RESOLUTION

To confirm the nomination of Mr. Peter Garamfel to serve as a member of the Board of Directors of the National Oceanic Resource Management Authority (NORMA), representing Yap State.

1 WHEREAS, pursuant to Public Law No. 15-38, section 201(1),
2 which amended title 24 of the Code of the Federated States of
3 Micronesia, the Federated States of Micronesia established a
4 five-member Board of Directors for the National Oceanic
5 Resource Management Authority; and

6 WHEREAS, pursuant to Public law No. 15-38, section
7 201(1)(b), the President of the Federated States of Micronesia
8 nominates one member from each state to serve on the Board of
9 Directors of NORMA, in consultation with each state governor
10 and with the advice and consent of Congress; and

11 WHEREAS, pursuant to Public Law No 15-38, section
12 201(1)(a), the President has nominated Mr. Peter Garamfel, a
13 nominee recommended by the Governor of the state of Yap, to
14 serve as the Yap State representative on the Board of Directors
15 of NORMA; and

16 WHEREAS, Mr. Peter Garamfel has the experience and
17 qualifications which make him a suitable candidate to serve on
18 the NORMA Board of Directors; now, therefore,

19 BE IT RESOLVED by the Nineteenth Congress of the Federated
20 States of Micronesia, Third Regular Session, 2018, that

1 Congress hereby confirms the nomination of Mr. Peter Garamfel
2 to serve as a member of the Board of Directors of the National
3 Oceanic Resource Management Authority, representing Yap State;
4 and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated
7 States of Micronesia, the Governor of each state of the Nation,
8 and Mr. Peter Garamfel.


