Approving and accepting a grant from the United Nations Children's Fund (UNICEF) in the amount of \$39,667, to fund and support the FSM's project entitled: "Expanded Programme on Immunization" in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Children's Fund (UNICEF)
2 issued a notification letter to funds transferred to the
3 Federated States of Micronesia on November 23, 2017, through
4 the Department of Health and Social Affairs in the amount of
5 \$39,667, to support and fund the Expanded Programme on
6 Immunization Project in the FSM; and

7 WHEREAS, the purpose of this a grant is to fund the in-
8 country capacity building for cold chain training in Pohnpei
9 State; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia, (Annotated), as amended,
12 requires that for foreign financial assistance to be valid it
13 must be approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twentieth congress of the Federated
15 States of Micronesia, Third Special Session, 2017, that
16 Congress hereby approves and accepts the \$39,664 from the
17 United Nations Children's Fund (UNICEF), to fund the Expanded
18 Programme on Immunization and its activities, including all the
19 terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia and the Secretary of the Department of
4 Health and Social Affairs.


