A RESOLUTION

Approving and accepting a grant from the Government of the People's Republic of China in the amount of \$1,200,000 to support the operation of the Y12 aircraft, including all the terms and conditions of the assistance.

1           WHEREAS, the Government of the People's Republic of China  
2 issued the Government of the Federated States of Micronesia a  
3 grant in the amount of \$1,200,000 to support one-year of  
4 operation of the Y12 aircraft; and

5           WHEREAS, section 210(2) of title 55 of the Code of the  
6 Federated States of Micronesia provides that for an agreement  
7 of foreign financial assistance to be valid it must be approved  
8 by Congress by resolution; and

9           WHEREAS the Government of the Federated States of  
10 Micronesia wishes to expresses its appreciation to the  
11 Government of the People's Republic of China for its generosity  
12 to the Federated States of Micronesia; now, therefore,

13           BE IT RESOLVED by the Twentieth congress of the Federated  
14 States of Micronesia, Third Special Session, 2017, that  
15 Congress hereby approves and accepts the \$1,200,000 grant from  
16 the Government of the People's Republic of China to support  
17 one-year of operation of the Y12 aircraft, including all the  
18 terms and conditions thereof; and




