Approving and accepting a grant in the amount of \$816,106 from the U.S. Department of Health and Human Services, Centers for Disease Control Prevention, to fund the project entitled: "To Accelerate the Prevention and Control of HIV, Viral Hepatitis, Sexually Transmitted Disease and Tuberculosis in the FSM and Pacific Islands", including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services,
2 Centers for Disease Control Prevention, issued a Notice of
3 Grant Award in the amount of \$816,106 based on the federal
4 grant application made on behalf of the FSM Government; and

5 WHEREAS, the purpose of the grant is to provide the
6 essential funding to implement the project entitled: "To
7 Accelerate the Prevention and Control of HIV, Viral Hepatitis,
8 Sexually Transmitted Disease and Tuberculosis in the Federated
9 States of Micronesia and Pacific Islands"; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia requires that foreign financial
12 assistance to be valid it must be approved by Congress by
13 resolution; and

14 WHEREAS, the FSM Government wishes to express its
15 appreciation to the Government of the United States for the
16 federal grant programs made available to the Federated States
17 of Micronesia; now, therefore,


18 BE IT RESOLVED by the Twentieth Congress of the Federated

2 Congress hereby approves and accepts the \$816,106 grant from
3 the U.S. Department of Health and Human Services, Centers for

5 "To Accelerate the Prevention and Control of HIV, Viral
6 Hepatitis, Sexual Transmitted Disease and Tuberculosis in the

11 States of Micronesia and the U.S. Embassy in Kolonia.


