A RESOLUTION

Approving and accepting a grant in the amount of \$45,000 from the Ministry of Foreign Affairs of the People's Republic of China, to the Department of Foreign Affairs of the Federated States of Micronesia, including all the terms and conditions of the assistance.

1 WHEREAS, the Ministry of Foreign Affairs of the People's
2 Republic of China issued to the Department of Foreign Affairs
3 of the Federated States of Micronesia, a grant in the amount of
4 \$45,000 as evident in the attached Letter of Agreement dated
5 December 21, 2017; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended,
8 requires that for foreign financial assistance to be valid it
9 must be approved by Congress by resolution; now, therefore,

10 BE IT RESOLVED by the Twentieth congress of the Federated
11 States of Micronesia, Fourth Regular Session, 2018, that
12 Congress hereby approves and accepts the \$45,000 grant from the
13 Ministry of Foreign Affairs of the People's Republic of China
14 to the FSM Department of Foreign Affairs, including all the
15 condition the terms and conditions thereof; and



5 China in Palikir.


