8 Caroline Pastoral Institute from 2005 to 2010; and

9           WHEREAS, Father Julio Angkel served our Nation and the  
10 region as a priest and community worker admirably, including  
11 work as the Vicar of Pohnpei and Kosrae from 2010 to 2015 and  
12 Director of the vocational and training office of the Holy  
13 Family Parish in Chuuk since 2015, and

14           WHEREAS, Father Julio Angkel will be consecrated and  
15 installed as Coadjutor Bishop with Right of Succession to the  
16 Diocese of the Caroline Islands on February 4, 2018; and

17           WHEREAS, the Congress of the Federated States of  
18 Micronesia wishes to express its sincere congratulations and  
19 appreciation to Father Angkel for his dedicated work and for

1 his consecration and installation as Coadjutor Bishop with  
2 Right of Succession of the Diocese of the Caroline Islands;


