A RESOLUTION

Approving and accepting a grant from the United Nations Development Program (UNDP), in the amount of \$145,193 to fund and support the Global Fund Project for TB/HIV in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Development Program extended
2 to the Government of the Federated States of Micronesia a grant
3 in the amount of \$145,193, as evidenced by a Project Document,
4 Work Plan, incorporating the description of SR activities,
5 deliverables and performance targets, time frames and budget,
6 and the special terms and conditions, and the Sub-Recipient
7 Agreement signed by both parties on January 30, 2018, and on
8 February 1, 2018, by the sub-recipient; and

9 WHEREAS, the purpose of the grant is to fund the project
10 entitled: "Western Pacific Multi-Country Integrated HIV/TB
11 Program" in the FSM for one (1) year starting January 1, 2018,
12 to December 31, 2018; and

13 WHEREAS, section 210(2) of title 55 of the Code of the
14 Federated States of Micronesia (Annotated), as amended,
15 provides that for an agreement on foreign financial assistance
16 to be valid it must be approved by Congress by resolution; now,
17 therefore,

18 BE IT RESOLVED by the Twentieth congress of the Federated
19 States of Micronesia, Fourth Regular Session, 2018, that

1 Congress hereby approves and accepts the \$145,193 grant from
2 the United Nations Development Program (UNDP), to fund the
3 Global Fund Project for TB/HIV in the FSM, including all the
4 terms and conditions thereof; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated
7 States of Micronesia and the Secretary of the Department of
8 Health and Social Affairs.




