A RESOLUTION

To confirm the nomination of Ms. Teresa M. Filepin to serve as the FSM Consul General in Guam, U.S.A.

6 Consul General of the Federated States of Micronesia; and

8 has nominated Ms. Teresa M. Filepin to serve as the FSM Consul
9 General in Guam; and

10 WHEREAS, Ms. Filepin is a suitable candidate to serve as the
11 FSM Consul General and qualified for this important position; now,

14 States of Micronesia, Fifth Special Session, 2018, that Congress
15 hereby confirms the nomination of Ms. Teresa M. Filepin to serve
