A RESOLUTION

Approving and accepting a grant in the amount of \$386,105 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to provide funding for the FSM program entitled: "Improving Health of the People of the FSM through Program Leadership and Management, Surveillance and Epidemiology, Health System", including all the terms and conditions of the assistance.

1 WHEREAS, U.S. Department of Health and Human Services,
2 Centers for Disease Control and Prevention, issued a Notice of
3 Award of financial assistance on March 3, 2018, in the amount
4 of \$386,105; and

5 WHEREAS, the purpose of this grant is to provide funding
6 for the FSM program entitled: "Improving Health of the People

8 Surveillance and Epidemiology, Health System"; and

9 WHEREAS, section 210 of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended,
11 provides that for an agreement on foreign financial assistance
12 to be valid it must be approved by Congress by resolution; now,

14 BE IT RESOLVED by the Twentieth Congress of the Federated
15 States of Micronesia, Fourth Regular Session, 2018, that
16 Congress hereby approves and accepts the \$386,105 grant from
17 the U.S. Department of Health and Human Services, Centers for
18 Disease Control and Prevention, to fund the FSM program

2 Program Leadership and Management, Surveillance and
3 Epidemiology, Health System" including all the terms and
4 conditions thereof; and
