A RESOLUTION

Approving and accepting a grant in the amount of \$106,291 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to fund and support the Community Mental Health Services Project in the FSM, for the budget period from October 01, 2017, to September 30, 2018, including all the terms and conditions of the assistance.

1 WHEREAS, on July 25, 2017, the United States through the
2 Department of Health and Human Services, Substance Abuse and
3 Mental Health Services Administration, issued a Notice of
4 Award of financial assistance in the amount of \$106,291 to
5 fund the Community Mental Health Services Project, managed by
6 the FSM Behavioral Health and Wellness Program; and

7 WHEREAS, the purpose of the grant is to fund and support
8 the implementation of the Community Mental Health Services'
9 Project and its activities in providing mental health
10 prevention services and treatment services to its patients
11 in the FSM; and

12 WHEREAS, section 210(2) of title 55 of the Code of the
13 Federated States of Micronesia (Annotated), as amended,
14 provides that for an agreement on foreign financial
15 assistance to be valid it must be approved by Congress by
16 resolution; now, therefore,

17 BE IT RESOLVED by the Twentieth Congress of the
18 Federated States of Micronesia, Fourth Regular Session, 2018,

1 that Congress hereby approves and accepts the \$106,291 grant
2 from the U.S Department of Health and Human Services,
3 Substance Abuse and Mental Health Services Administration, to
4 fund the FSM Community Mental Health Services Project and its
5 activities, including all the terms and conditions thereof;
6 and

7 BE IT FURTHER RESOLVED that certified copies of this
8 resolution be transmitted to the President of the Federated
9 States of Micronesia, the Secretary of the Department of
10 Health and Social Affairs, and the U.S. Embassy in Kolonia.


