A RESOLUTION

To confirm the nomination of Mr. Takuro Akinaga to serve as the Chief Executive of the Office of the Telecommunication Regulation Authority of the Federated States of Micronesia.

1           WHEREAS, pursuant to section 306 of title 21 of the Code  
2 of the Federated States of Micronesia (Annotated), as amended  
3 by Public Law No. 18-52, the President of the Federated States  
4 of Micronesia shall appoint the Chief Executive of the Office  
5 of the Telecommunication Regulation Authority (the  
6 "Authority"), subject to the advice and consent of Congress,  
7 for a term of four years; and

8           WHEREAS, the President has nominated Mr. Takuro Akinaga to  
9 serve as the Chief Executive of the Authority; and

10           WHEREAS, Mr. Akinaga has professional experience and  
11 qualifications, which make him a suitable candidate to serve in  
12 this capacity; now, therefore,

13           BE IT RESOLVED by the Twentieth Congress of the Federated  
14 States of Micronesia, Fourth Special Session, 2018, that  
15 Congress hereby confirms the nomination of Mr. Takuoro Akinaga  
16 to serve as the Chief Executive of the Office of the  
17 Telecommunication Regulation Authority; and

4 and Mr. Takuro Akinaga.


