RESOLUTION

Approving and accepting a grant in the amount of \$2,963,151 from the U.S. Department of Education for the Federal Fiscal Year 2019 fund under Part B of the Individual with Disabilities Education Act (IDEA), including all the terms and conditions of the grant.

1           WHEREAS, the United States through the Department of  
2 Education issued a Notice of Award on September 27, 2018, for  
3 Phase 2 for the federal funding period from July 01, 2018, to  
4 September 30, 2019, in the amount of \$2,963,151; and

5           WHEREAS, the purpose of the grant is to fund and assist  
6 the implementation for the FSM Department of Education,  
7 Division of Special Education programs and services provided to  
8 eligible children with disabilities including their families  
9 throughout the FSM; and

10           WHEREAS, section 210(2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended,  
12 requires that for foreign financial assistance to be valid it  
13 must be approved by Congress by resolution; now, therefore,


14           BE IT RESOLVED by the Twentieth Congress of the Federated
