14 Board members shall serve a term of four years; now, therefore,

15 BE IT RESOLVED by the Twentieth Congress of the Federated
16 States of Micronesia, Sixth Regular Session, 2019, that Congress
17 hereby confirms the nomination of Mr. Ihlen K. Joseph to serve as
18 a member of the Board of Trustees of the FSM Trust Fund of the
19 Federated States of Micronesia; and

3 of Micronesia, the Governor of each state of the Nation, and Mr.
4 Ihlen K. Joseph.




