5 Trust Fund, subject to the advice and consent of Congress; and

6           WHEREAS, the President has nominated Mr. Fabian S. Nimea  
7 to serve as a member of the Board of Trustees of the FSM Trust  
8 Fund; and

9           WHEREAS, Mr. Fabian S. Nimea has the experience and  
10 qualifications which make him a suitable candidate to serve on  
11 the Board of Trustees of the FSM Trust Fund; and

12           WHEREAS, pursuant to section 1208 of title 55 of the Code  
13 of the Federated States of Micronesia (Annotated), as amended,  
14 Board members shall serve a term of four years; now, therefore,

15           BE IT RESOLVED by the Twentieth Congress of the Federated  
16 States of Micronesia, Sixth Regular Session, 2019, that Congress  
17 hereby confirms the nomination of Mr. Fabian S. Nimea to serve as  
18 a member of the Board of Trustees of the FSM Trust Fund of the  
19 Federated States of Micronesia; and

3 of Micronesia, the Governor of each state of the Nation, and Mr.


