A RESOLUTION

Urging and authorizing the President to seek on behalf of the Federated States of Micronesia membership in the United Nations Industrial Development Organization (UNIDO).

1           WHEREAS, the United Nations Industrial Development  
2 Organization (UNIDO) is a specialized agency for the United  
3 Nations, the primary objective of which is the promotion and  
4 acceleration of industrial development in the developing  
5 countries, it also promotes industrial development and  
6 cooperation on global, regional and national, as well as  
7 sectoral levels; and

8           WHEREAS, in fulfilling its objectives, UNIDO performs key  
9 functions, such as encouraging and extending assistance to  
10 developing countries in the promotion and acceleration of their  
11 industrialization, coordination of activities in the UN system  
12 in the field of industrial development, and serving as a  
13 clearing-house for industrial information and accordingly  
14 collect and monitor on a section basis, analyze and generate  
15 for the purpose of the dissemination of information on all  
16 aspects of industrial development on global, regional, national  
17 and sectoral levels; and


18           WHEREAS, membership in the UNIDO could be beneficial to

5 Organization; and;


6 BE IT FURTHER RESOLVED that certified copies of this
