1 WHEREAS, the United Nations Environment Programme
2 (UNEP) extended to the Federated States of Micronesia a grant in
3 the amount of \$250,000 to provide funding for the project
4 entitled: "Strengthening Institutional Capacity for Chemical
5 Management in the FSM"; and

6 WHEREAS, the grant is evidenced by a letter dated 26 February
7 2019 by the UNEP addressed to the Secretary of the FSM Department
8 of Environment, Climate Change and Emergency Management; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; and

13 WHEREAS, the Government of the Federated States of Micronesia
14 wishes to express its appreciation to the United Nations
15 Environment Programme for this generous grant; now, therefore,

16 BE IT RESOLVED by the Twentieth Congress of the Federated
17 States of Micronesia, Eighth Special Session, 2019, that Congress
18 hereby approves and accepts the \$250,000 grant from the UNEP,
19 including all the terms and conditions thereof; and

4 Secretary of the Department of Foreign Affairs.




