A RESOLUTION

Approving and accepting a grant in the amount of \$7,400,000 from the Government of Japan to assist the Government of the Federated States of Micronesia Disaster Risk Reduction related projects for the fiscal year April 2019 to March 2020 with the United Nations Development Programme (UNDP) as the implementing agency, including all the terms and conditions of the assistance.

1           WHEREAS, the Government of Japan pledged \$7,400,000 during  
2 the 19<sup>th</sup> Micronesian Presidents Summit held in Palau in February  
3 of 2019, to assist the Government of Federated States of  
4 Micronesia in the field of disaster prevention and mitigation;  
5 and

6           WHEREAS, the purpose of this grant will assist the FSM  
7 Disaster Risk Reduction related projects in the FSM for the  
8 fiscal year April 2019 to March 2020, with the UNDP as the  
9 implementing agency; and

10          WHEREAS, section 210(2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended,  
12 requires that for foreign financial assistance to be valid it  
13 must be approved by Congress by resolution; now, therefore,

14          BE IT RESOLVED by the Twentieth Congress of the Federated  
15 States of Micronesia, Eighth Special Session, 2019, that  
16 Congress hereby approves the \$7,400,000 grant from the  
17 Government of Japan including all the terms and conditions  
18 thereof; and

1           BE IT FURTHER RESOLVED that certified copies of this  
2 resolution be transmitted to the President of the Federated  
3 States of Micronesia, the Secretary of the Department of  
4 Foreign Affairs, the Secretary of the Department of Justice,  
5 the Secretary of the Department of Finance and Administration  
6 and the Japanese Embassy in Kolonia.




